

Minutes of meeting:


- The committee reviewed the suggestions given by the AMC and decided to take part in Transparence18 & INSDAG competitions by taking the briefs as studio projects for 4th year.
- Also, it was decided to compete in Solar Decathlon (Conducted by IHS & SDI) and studio projects for the 3rd year were selected accordingly to meet the competition requirements.
- The incentives received from Saint Gobin for taking Transparence17 as a studio project is decided to be taken as add on courses for students across batches.
- PMCA collaborated with Ethos foundation to conduct a walking studio which will include all the schools of architecture in Odisha, with an aim explore the architecture of the rich heritage of certain lesser-known art and craft of Puri and nearby areas through walking and interacting with people involved in it. This was taken as a part of collaborative activity with Ethos as per the MoU.
- Activities of the induction program for the first year were finalized.
- The committee was apprised about the rescheduling of the academic calendar of the college as per the university schedule and the receipt of 2(f) letter from the UGC.

- Mr. D. K.Panda was entrusted the task of preparation of the requisite documents for uploading to apply for autonomous status.
- A proposal to observe annual NASA day on 27th September in the campus along with the students of architecture of Cuttack and Bhubaneswar was discussed and decided to organise the same.
- The first batch of PMCA is going to complete their 25 years and to mark the occasion PMCA alumni association had given certain proposals which were reviewed and the date was tentatively finalised.
- Also to celebrate 31st Foundation Day of the college, it was decided to put up students work in an exhibition for public where the special invites are schools, the parents, and architects.
- Apart from this representation of the college in various workshops, state and national level events and competitions were emphasised upon.
- Proposals submitted by different clubs of PMCA, were also discussed, and finalized. More activities related to societal concern and social outreach were proposed to increase further more.
